Description:

This two and half day workshop will introduce the basic laws, regulations and project approval process under the California Environmental Quality Act (CEQA) and permitting under the California Endangered Species Act (CESA) for State and federal regulatory biologists, government and private wildlife biologists, natural resource specialists, environmental planners and students.

The Workshop will cover:

- Historical context and background information related to CESA as we know it today;
- ♦ An overview of the "listing" process under CESA: from submittal of the petition to the candidacy determination, and from status review to the final determination by the Fish and Game Commission; along with current trends in the arena, both in and out of court
- ◆ An overview of what constitutes "take" under CESA, as compared to the federal ESA, as well as an introduction to incidental take

permitting under CESA and other take mechanisms available under state law.

- ♦ The workshop will provide the basics of CEQA as it pertains to a project. They will cover "What is a project?" What are and when do statutory and categorical exemptions apply.
- ◆ Start from the Very Beginning: Basic CEQA Context, When CEQA Applies (what is a project), Statutory and Categorical Exemptions
- ♦ How do I know what document I need? Negative Declarations, Mitigated Negative Declarations, and Environmental Impact Reports
- ◆ Process and the Product: What do these reports need to cover? How does a document make its way in the world?
- ♦ Where the Rubber Meets the Road: Impacts and Mitigations. What is meant by "significant?" What makes a mitigation work?
- ♦ CEQA and HCPs looking at a few case studies.
- ♦ Bumps in the road what slows the process down?
- ♦ What is happening in the Courts?
- ♦ What other laws/regulations commonly interact with CESA/CEQA?
