

### **President's Message** Scott Osborn

It was an accident, but it was hard for me not to interpret it with superstitious suspicion. I had just missed our Newsletter Editor's third or fourth deadline extension for this column. Instead of writing, I was adjusting the bookshelves in my home office to accommodate several new large books I recently acquired. As I worked, the shelving unit wobbled a bit and then suddenly the Western Section's Perpetual President's Trophy came crashing down onto my head. The PPT is a nice, hefty chunk of hardwood with lots of edges and sharp corners. After cutting open my scalp (no stitches required - but there was blood and it hurt!), the trophy also scraped the paint and dented the wall next to the bookshelves. After a couple seconds of disorientation and pain, I realized what had happened, and then my tendency towards superstition kicked in: This had to be a message from Past Presidents, living and dead, to get back to work on Section business!

But where to begin? I had been taking a procrastinator's holiday from Section work since the end of the annual conference in January. There were a dozen high-priority tasks on my list, each of which would require precious time to complete. Time, of course, always seems to be in short supply. I've read that people who take on too many



projects and commitments tend to be insecure and unsure about their own abilities. Under this theory, perfectionism and procrastination are two personality traits that allow a person to avoid judgment by others and provide an excuse when the person's own high expectations of himself inevitably fall short. That may be true about me, but what about all the other folks I know who are constantly overcommitted in their work and personal lives? When I ask my colleagues at Fish and Game and elsewhere how things are going, the almost inevitable response is "there's too much to do!" Is it possible that virtually every professional wildlife biologist I know suffers from the same character flaws that I do?

Or is it possible that there truly is just too much work to do? With nearly seven billion people on the planet, you'd think there would be plenty of people to help out with the job of managing and conserving wildlife resources. Unfortunately, wildlife biologists remain a tiny minority of the total population, even in developed, well-educated countries like the United States. And, of course, the large human population and its general disregard of the environmental consequences of its actions are the primary causes of most of the management and conservation challenges we deal with in our work. So, too many challenges and not enough people to deal with them seem to inherently go hand-in-hand.

And don't get me started on information! Can a person keep up with scientific literature and other information relevant to our profession anymore? I was astounded when one of our esteemed recent Past Presidents told me he has read every article that has been printed in the Wildlife Professional since its inception a couple years ago -- I've only managed to skim through most issues and have actually read very few of the articles, despite the high quality of the publication. More troubling is the difficulty I have in keeping up with primary literature, with so many journals publishing articles that are relevant to my work. How can I be effective in my job when I am not aware of the latest research that could inform our thinking about a particular resource challenge?





# Program Chair Wrap-Up Scott Osborn

The Western Section's 2009 annual conference in Sacramento was a success, despite the Program Committee's grave concern regarding turnout. Almost daily bad news about the economy preceded the conference and many companies and agencies had placed travel and training restrictions on their employees. So, as expected, attendance at the conference was low, with a total registration of approximately 350 persons, which is about 70 less than the average of the past several years. Despite the low turnout, the conference had a net income of about \$15,000. The annual budget for the Section relies on income from the conference, as well as from annual dues, to support the core operations of the Section. So it was a huge relief to the Executive Board that the conference did not lose money.

The conference program was diverse and interesting, though again modest because of the relatively low turnout. Approximately 75 papers and posters were presented in 11 sessions during the two-and-a-half days of the conference (see figure). This year, the sessions were arranged primarily by habitat types, with a few technique and general topic sessions thrown into the mix. I was interested to see that several habitat types, including alpine/ sub-alpine, broad-leaved forests, chaparral, and herbaceous-dominated habitats, had either no or too few submissions to stand on their own as separate sessions. And I was dismayed, but not surprised, that the human-altered ecosystems session was the second-largest session during the conference. Both the general topic sessions ("Wildlife Diseases" and "Hunting, Trapping, and Wildlife Management") were new this year and, in my opinion, are important topics to maintain as discrete sessions.



Likewise, with the techniques sessions ("Genetics" and "Electronic Technology" as well as the "Statistical Innovations" session that didn't materialize) I'd like to continue to see focused sessions address these important, rapidly-evolving modes of inquiry.

The Plenary Session theme this year was "The View from the Future: Wildlife Management Challenges and Opportunities of the Next 100 Years." Five invited speakers painted a picture of the challenges wildlife professionals may expect to face in the coming century. Technical topics covered by David Graber, Juliet Christian-Smith, and Michael Reilly included climate change, water policy, and human population growth. Kevin Hunting discussed the challenges and opportunities for wildlife managers that arise during economic downturns. And John Perrine riveted the audience with his essay on the sense of community that comes from participation in TWS. If you missed John's presentation, you will likely get a chance to read the essay in an upcoming TWS or Western Section publication – I highly recommend it!

The conference also included two workshops and two informal working group meetings. Katie Moriarty and Darla DeRuiter taught an Orienteering Workshop immediately before the conference began. Barbara Peters taught a Resume Workshop on Thursday morning. The Fisher Working Group met Friday morning and the Red Fox Working Group met Friday afternoon. There was also a well-attended Career Fair and Student-Professional Lunch on Friday.

A common theme of the conference evaluations we received was that the Sheraton Grand Hotel was a nice venue, but too expensive. With daily parking costing \$15 and rooms well over government rates, most conference attendees staying at the hotel had to pay more than they liked or were reimbursed for. The Program Committee and Executive Board heard your complaints and will be working to ensure that future conference hotels are more affordable.

A Program Chair, I would like to thank all the members of the Program Committee who worked on behalf of the Section to make the conference a success. I was very impressed with the willingness of others to take on the many diverse tasks that must be accomplished to pull off a conference of this size. I also thank all the presenters of papers and posters for sharing the results of their work with the conference attendees. And, of course, thanks to all who attended the conference despite the difficult economic times.

### President-Elect Armand Gonzales

I would like to thank all of you for your support, electing me to be the new President-elect. I am looking forward to the challenges and opportunities that lay ahead. I have begun planning for the 2010 annual meeting in Visalia. This will be a great opportunity to focus on the San Joaquin Valley and the many conservation planning activities that are ongoing at the local, state, and federal levels there. If you would like to help with the planning or have any ideas for what would be important to highlight, please give me a call.

I am truly appreciative and amazed by the commitment of the Board, committee members, and the membership, all working towards common interests in wildlife management. There are always differing opinions about how we care for and manage the resources we know and love, and we make personal and professional choices based on our values and ethics developed over time. I often think about how much of what I learned about wildlife management in school and throughout my career has changed. The baseline has shifted and no longer are we talking about optimal outcomes, but rather manageable outcomes with consequences we can live with.

So, what will wildlife management be in fifty years? Will we have made the right choices? It's going to be crazy with all those millions of new people projected to populate California. Climate is not the only thing that's going to be changing. Whether and how we can apply the lessons learned during the good ol' days to an uncertain future will be our challenge as wildlife professional's to figure out. We, along with the wildlife in our charge will have to adapt, perhaps beyond our comfort zone in order to survive.

### Treasurer Gary Falxa

The Section continues to be in a strong fiscal position, thanks to several strong years, which have built up reserves. The Section ended 2008 with well over \$100,000 in assets, representing an increase of more than \$30,000. We stayed within our expense budget for 2008, and, thanks to a well-attended 2008 annual conference in Redding and several successful workshops, actual income exceeded our budget estimate. We can all be proud that in 2008, the Section spent a total of about \$15,000 in various grants and awards. In addition to student travel and research grants, this included donations to TWS National for the 2008 annual meeting in Miami, and to a trust fund, in honor of Barry Garrison.

With the Section's success over recent years, our assets are now sufficient to merit an investment strategy that goes beyond simple savings and checking accounts, where interest rates are low at best. Currently, the Section's assets are all in insured savings, checking, and CD accounts. Over the coming year, I will work with the Section's executive board to develop a long-term financial strategy for managing the Section's assets to maximize returns while minimizing risk. Also, the receipt in January of a generous bequest from the Donaldson Family Trust (more information: Summer issue) has invigorated plans to start building the Section's new Endowment Fund.



Looking forward into 2009, the recession likely impacted attendance at the recent annual conference in Sacramento, as many from the public and private section faced funding and travel restrictions. As a result, net income from the conference—about \$15,000, was lower than we've seen in recent years.

In summary, the Section continues to be financially solid. We have no outstanding debt, considerable income has been made each of the past several years, and our bank deposits are substantial. We know that 2009 income may be lower than normal, because of the current global fiscal problems that affect us all. Due to measures taken in recent years to reduce the Section's fixed expenses, and the Section's robust financial condition, the Section is in a good position to weather a year or two of below-average income.

intend to make all previous Transactions accessible on the web soon, and the 2008 edition later this year.

Perhaps a bigger question is this: Does that seem fair? Would you NOT renew your membership if we made Transactions available to the world immediately? Do you perceive value from your Western Section membership in other ways? We charge \$20 for annual Western Section membership, and if you attend one typical workshop or our annual meeting, you usually save about \$35 by being a member. We provide a newsletter, e-mail updates of our actions, an ever-changing website, and more for that \$20. So, again, "what do you think?" Is giving YOU, the membership, early access to our Transactions something that we should continue to do as a benefit of your Section membership, or is it just not that important? ### **Newsletter Editor**

A number of years ago, the Western Section Executive Board voted to save costs and resources by distributing newsletters electronically. When Section finances allowed, we voted to print a single issue of our newsletter, the Winter edition, to make sure elections and conference information were made available to all current and recent members in our database. Semi-annual issues are posted to the website and distributed electronically, This change took advantage of our improved electronic resources (website and members' listserve) while significantly reducing cost and resources; a single printed issue mailed to all members costs the Section from \$1,100 to \$2,000 and consumes 22,000 sheets of paper.

During our January 2009 Executive Board meeting, I was asked to revise our newsletter publishing strategy and to find a new publishing house for both printing and distribution. In developing the revised strategy, I considered costs, effort, sustainability, effectiveness of readership and readability for members.

My proposal is as follows:

- 1) Continue printed distribution of the Winter issue, reduce issue length, and move the publish date up to November 1st.
- 2) Publish quarterly electronic issues in Spring, Summer, and Fall; distribute 200 printed copies of each issue to members who request printed copies and institutional addresses including colleges and universities, agencies, and consulting firms.
- 3) Consider publishing electronic issues in html format to improve readability; providing links to web-based references and resources.

I attended the mid-year TWS Council meeting in Arlington, VA in March. Luckily, so far TWS has been spared from dramatic effects of the current economic downturn. Like most everyone else, some of TWS' investments have lost value; however, our membership remains strong - helping buffer our operations for 2009. Hopefully that means that our membership is weathering the economic storm and are ready to help support the many resource based economic stimulus projects occurring across the nation and in our own backyards.

Council is aware of the seriousness of the economic situation and we've agreed to a special meeting to evaluate the recently approved Strategic Plan. If so, thank you for your contribution to ensuring that your professional society remains strong and among other things: 1) is able to represent you in Government Affairs and express our collective voice on policy issues; 2) is able to produce the quality members magazine, The Wildlife Professional, in addition to our Journal of Wildlife Management; and 3) is able to support professional development by providing a high-quality Conference (hosted by us in September!), a Certification program for professionals and soon, Wildlife Technicians, and offer development opportunities for young professionals, who are our future leaders. If you aren't a member of TWS, I ask you to reflect personally on YOUR wildlife profession and consider how affiliation at the national/international level demonstrates your commitment to your chosen profession and to wildlife resources in general. It isn't just about TWS collecting your dues, it's about you gaining tangible and intangible benefits from supporting and being affiliated with TWS.

In these tough economic times, I realize it's hard to ask you to dig in your pocketbook and pay yet another set of dues. But I challenge you, if not you, then who will support the voice of wildlife professionals? And in these times when environmental changes are rapidly occurring and policy decisions must be made with the incomplete and sometimes conflicting information that's available, don't you want our greatest strength - our science-based approach, as the centerpiece of decision-making? Our strength as a professional society will reflect in how much we are asked to be at the table (or how often we invite ourselves) in these important issues that affect our wildlife resources. We also provided hotel rooms for members of the Humboldt State University Student Chapter to boost student attendance at the annual conference. In March we organized a biologist breakfast to facilitate discussions among local biologists on local issues, coordination of surveys, and sharing of new information. The meeting was well attended; 25 professionals discussed various topics including spotted owls, the expansion of barred owls into the area, marbled murrelets, and fishers.

In April the Chapter held its annual awards banquet in conjunction with the

HSU Chapter Beast Feast. Sandra Hunt von Arb was presented with the Professional of the Year award, Mark Colwell was presented with the Conservationist of the Year award, and Jeanette Griffin was presented with the Student of the Year award for the second time (this is the first two-time win ever in Chapter history for this award).

The fall mixer was well attended with approximately 80 in attendance, including many new faces. In December we held the winter mixer. The roughly 100 participants enjoyed a dinner of chicken and potluck items. Annual elections yielded new officers: Ken Moore (President Elect); Leslie Tucci (Secretary); Jesse Sargent (HSU Chapter Representative). We now have a newsletter editor and she has revamped and updated our webpage.

The Chapter provided a grant for research on plover to Kevin Brindock, sponsored travel for an international guest speaker, Dr. Reuven Yosef who gave an outstanding lecture in September, and sponsored the National meeting in Miami.

### Hawaii

During 2008, the Hawaii Chapter continued to sponsor a number of wildlife conservation projects throughout the state. We have continued our participation as a partner with the Hawaii Department of Land and Natural Resources (DLNR) and the U.S. Fish and Wildlife Service (USFWS) in a cooperative effort to construct a predator-proof fence and remove all alien mammals within the proposed fence at the Kaena Point Natural Area Reserve on the island of Oahu. Once completed, the project will create a 59-acre area of coastal habitat free from alien mammals, including feral dogs, cats, mongooses, and rodents,

which routinely damage or kill a variety of endangered and native species.



The Hawaii Chapter also teamed up with the Conservation Council of Hawaii (CCH) and supplied matching funds to those provided by the Hawaii Tourism Authority to produce wildlife viewing panels at selected Hawaiian habitats featured in the Hawaii Watchable Wildlife Guidebook. Signs for forest birds, waterbirds, sea turtles, monk seals, and whales and dolphins are being produced and will be placed in appropriate wildlife viewing areas throughout the state. The chapter once again participated in the Hawaii Conservation Conference (HCC) in 2008, both through financial support of awards for best student presentation and best student poster, and the University of Hawaii Hawaiian Internship Program (UH-HIP). Chapter members participated in a well-attended Young Professionals Gathering and will be helping to organize a career fair at this year's HCC.

### **Humboldt State Univ.**


